Installation:

1. ENSURE POWER IS SWITCHED OFF PRIOR TO INSTALLATION.

- 2. Locate a suitable location to install the controller. Make sure no object covers the light sensor (B).
- 3. This unit is designed to connect to a maximum 60W 12V DC power supply.
- 4. Keep the controller and power supply away from any direct sources of heat such as hot water system, air conditional and fire place.
- 5. Plug the extension cable (A) into 12V DC power supply (60W max).
- 6. Plug existing light into connector (C).
- 7. Check all the connections prior to turning on the main switch power.
