
- 1. ENSURE POWER IS SWITCHED OFF PRIOR TO INSTALLATION.
- 2. Locate a suitable or desire location to install the garden light.
- 3. This unit is designed to connect to a 12V DC power supply.
- 4. Keep the light away from any direct sources of heat such as hot water system, air conditional and fire place.
- 5. Plug the 2 pin connector (G) into a 12V DC power supply (NOT INCLUDED).
- 6. If you have more than one light, plug the next light 2 pin connector (G) into the previous light 2 pin plug splitter (F). Ensure the power of the total number of lights connected are not exceed the 12V DC power supply.
- 7. Loosen the light head locking screw (D) to adjust the angle of the light you desired. After that tighten the light head locking screw.
- 8. Ensure all the cables screw nut are screwed in tightly and firmly to meet the IP 68 rating.
- 9. Check all the connections prior to turning on the main switch power.








